CONDITIONS

1. The photographic copy may be used only once and only for the purpose listed in the "Description of Proposed Use." Any subsequent or different use (including subsequent editions, book editions, paperback editions, different languages, etc.) constitutes a reuse and must be applied for in writing. An additional fee may be charged for reuse.
2. The photograph must be properly credited. The following is the basic credit line: Idaho State Historical Society. Photograph number and the photographer's name (if known) must also be included in the credit line. It is mandatory that you credit as specified.
 - a. With printed matter, the credit line should appear on the same or facing page as the illustration, or in a credit note at the end of the book or article. Photograph numbers must appear either near the illustration or at the point of credit. Crediting of each individual item is mandatory in all cases.
 - b. With films, filmstrips, slide presentation, and videotapes, include the credit with list of other sources of illustrations.
 - c. With displays or exhibitions, credit within the display/exhibition area.
3. The Idaho State Historical Society must receive one complimentary copy of any published work except motion pictures or videotapes, in which the photographic copy appears.
4. The user may not permit others to reproduce the photographic copy or any facsimile of it.
5. The user may not reproduce the photographic copy as a dust jacket or an end paper, nor use in an advertisement or any commercial use of a similar nature, nor mass reproduce as unbound material, unless specifically authorized by a "Letter of Permission."
6. In authorizing the publication or use of a photographic copy, the Idaho State Historical Society does not surrender its own right to publish it, or to grant permission to others to do so.
7. The Idaho State Historical Society does not claim to control the copyright for photographs and other pictorial material in its collections. Users assume all responsibility for questions of copyright that may arise in copying and the use made of the photographic copy. The Library and Archives will provide any available information about particular items to the user.
8. The Idaho State Historical Society reserves the right to limit the number of photographic copies; to restrict the use of reproduction of rare and valuable material; to levy special use fees in unusual circumstances.
9. Any exceptions or additions to the above conditions will appear on, and be considered part of, the letter-agreement.
10. Failure to comply with these conditions will result in revocation of permission and denial of service in the future.
